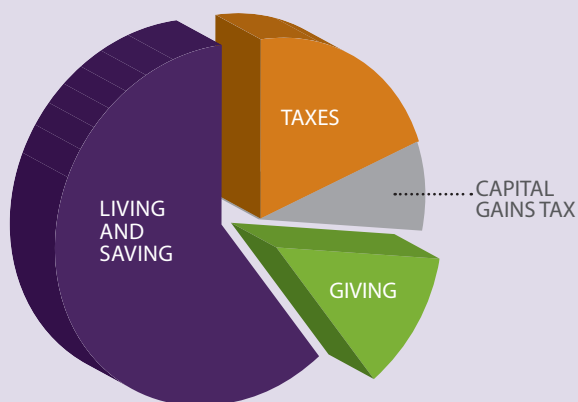

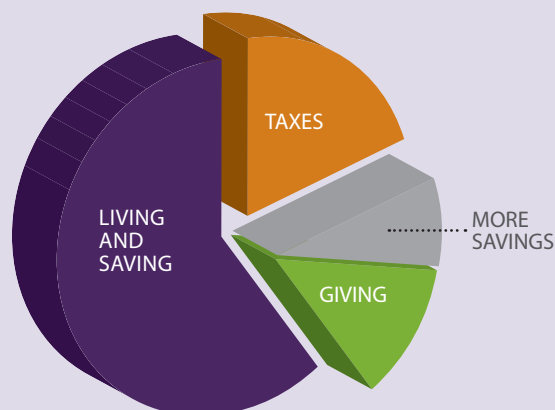
An Opportunity for Tax-Wise Giving
